TERMS AND CONDITIONS

Cancellations received on or prior to 4 August 2023:

Full Refund less a 10% (of the registration cost including any additional addons) per person administration fee.

(Note: Substitute can attend if the registrant is not able to get to the event).

Cancellations received on and after 5 August 2023:

No refund.

(Note: Substitute can attend if the registrant is not able to get to the event).

No refund will be given for non-attendance.

(Note: Substitute can attend if the registrant is not able to get to the event).

In the unlikely event of the symposium being cancelled by the organiser, the organiser will provide a full refund less administration fee. Liability will be limited to the amount of the fee paid by the delegate and there will not be any additional liability to the Organiser, event hosts or any other individual associated with the event organisation.

We shall not be liable to you for travel, accommodation or other costs and expenses incurred if we are required to cancel or relocate the event.

Cancellation Due to Travel Restrictions

Where the participant cancels due to travel restrictions other than vaccination or testing requirements, the participant will be contacted and offered a refund, where such an offer is at the discretion of the organiser.

The organiser reserves the right to withhold some monies to cover administrative expenses and other losses, dependent on when notice of cancellation is given by the participant
